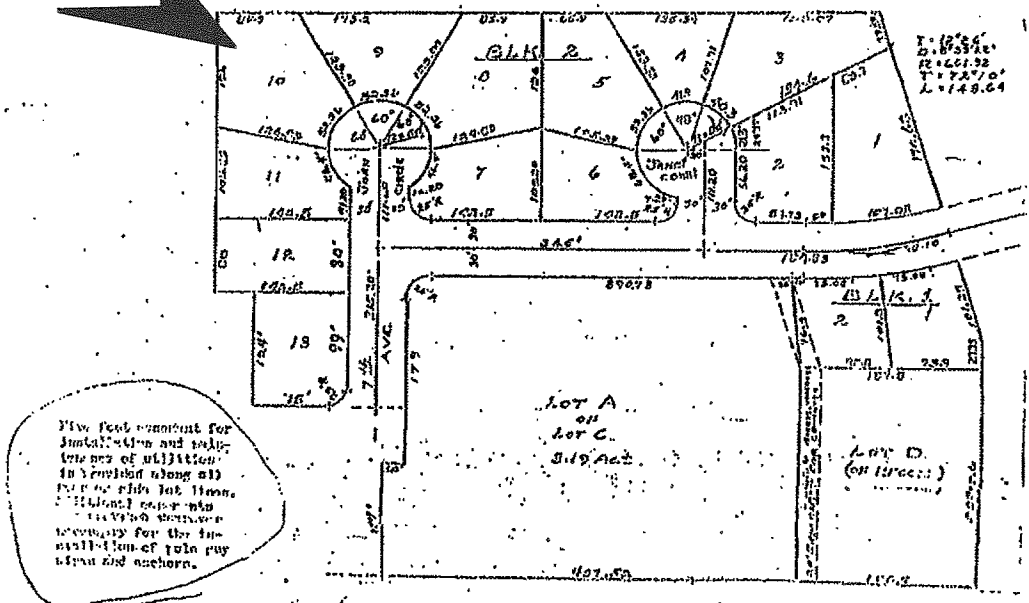
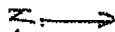


PLAT OF

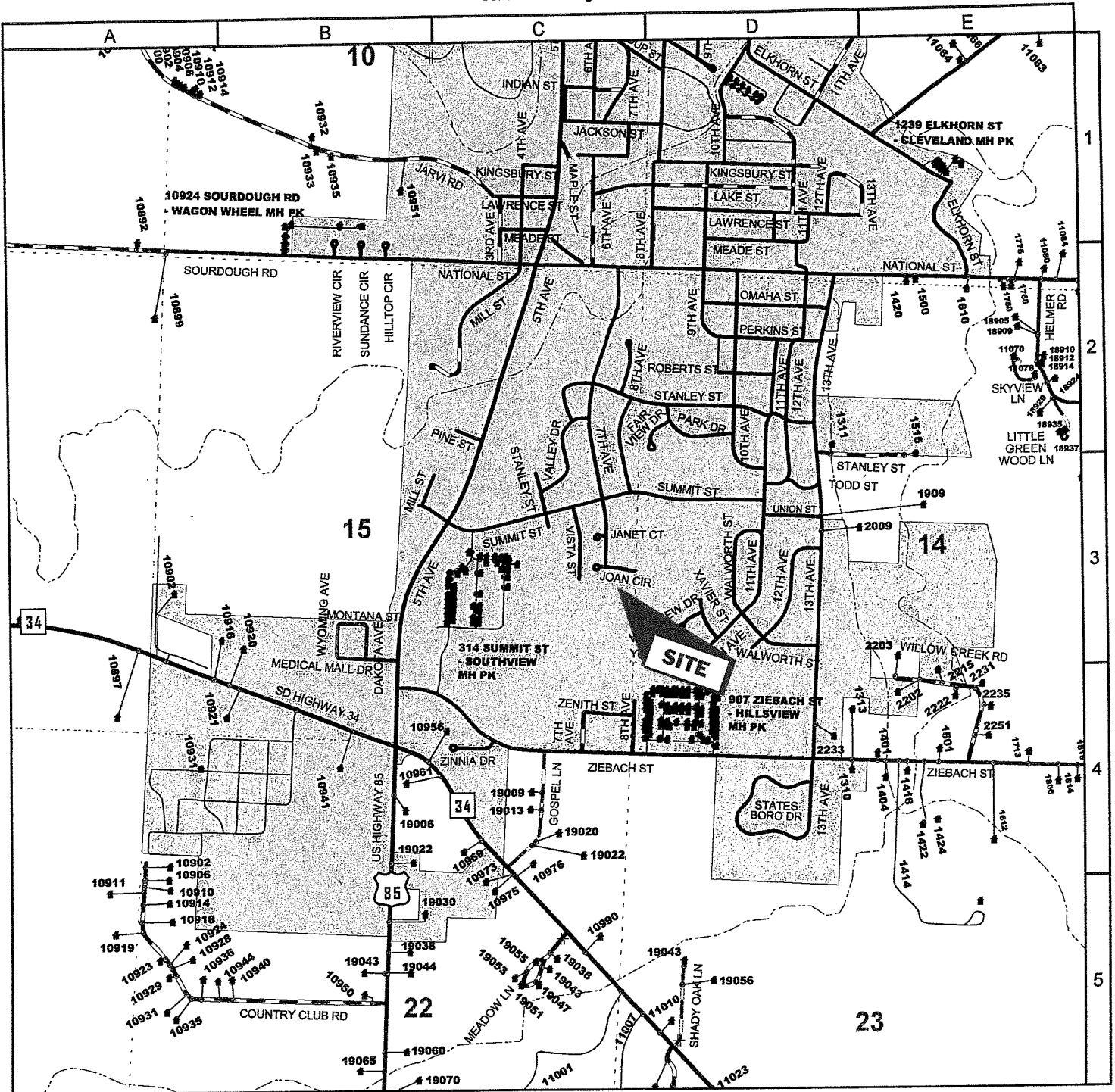
